Balance of unused Extended Leave

Why is this question being asked?

To calculate your unused Extended Leave entitlements, HR eXpert needs to know an up-to-date balance of your unused Extended Leave. HR eXpert will then calculate how much Extended Leave will accrue between then and the relevant date.

How do I answer this question?

Enter the amount of your Extended Leave balance in hours, to two decimal places, in the following format:

730; 141.5; 52.25

Enter the date to which your Extended Leave balance applies. This cannot be a date in the future, you will need to enter a date that is no later than today's date.
