Your story

I am an ecologist of over 40 years experience having a professional knowledge of the ecosystems of Australia, particularly the NSW North Coast. I have been a NPWS Ranger with fire fighting experience. I live at Coutts Crossing which was threatened by the Liberation Trail Fire in November 2019. My wife and I evacuated our home in the village of Coutts Crossing and stayed for 5 nights with friends at Woodford Island. These friends helped us to evacuate partly because I had only returned from an operation in Sydney where I had a defibrillator implanted in my chest 3 weeks earlier and could not drive at the time. The stress of evacuating, on top of my hospitalisation and operation, affected my health but the support of family and friends allowed me to cope. I was also very stressed to learn about the loss of over 80 residences in the nearby village of Nymboida. I am a councillor on Clarence Valley Council and as such felt obliged to help but was unable to do too much due to my medical condition and evacuation situation. A number of friends and associates lost their homes, some losing all their possessions as well. We were the lucky ones as the fire was controlled about 8 km from our village. The potential loss of our home was also felt by

our children who grew up in the house but now live in Coffs Harbour, Sydney and Brisbane. I still get emotional at times thinking back to that time although my emotions are mixed as the catastrophe brought out the best in many people. The community spirit at Nymboida and the donations from people all over Australia was very heartening. As an ecologist I want the future management of bushfires to be scientifically based and not based on a knee-jerk political reaction.

Terms of Reference (optional)

The Inquiry welcomes submissions that address the particular matters identified in its Terms of Reference.

1.1 Causes and contributing factors

The main causes of the catastrophic bushfires late last year and early this year were the extreme drought conditions which were likely to be exacerbated by the effects of climate change, causing the extreme drying out of vegetation making it more fire prone. Some fires were due to hazard reduction burning that escaped and others were due to arson but the extreme conditions were due to drought and climate change. It was NOT due to insufficient hazard reduction burning. Areas that had been hazard reduced in the months leading up to the fires also burnt severely. Some hazard reduction burning may be of value but to have politically based directions to burn a certain percentage of the protected estate is fraught with danger. When this was introduced a few years back government officers had to burn areas that were not a bushfire hazard just to meet artificial targets. Any scientifically supported hazard reduction burning should consider indigenous burning as a guide to how and when it should be carried out. It should also be noted that the window of opportunity to carry out hazard reduction burns is narrowing each year due to the impacts of climate change.

1.2 Preparation and planning

State agencies are generally prepared for the bushfire season but weren't expecting such an extended and intensive season as the last one. Individuals should have a fire plan and carry out reasonable activities to reduce fuel loads near residences. This has to be balanced with the ecological value of native bushland as many people live where they do to live with nature. Too much clearing can reduce the ecological value of bushland areas and may not save homes anyway. Local councils should only approve homes in low bushfire risk areas or approve homes that are built of fire-resistant materials. State and federal governments need to adequately fund the fire fighting agencies and unfortunately the state government reduced the numbers of experienced and qualified fire fighting staff in agencies like the National Parks & Wildlife Service. Only hazard reduction burns that are likely to have a real benefit should be carried out and not in the dry season, which is winter and early spring in northern NSW.

1.3 Response to bushfires

The agencies responded well but apparently did not expect the extreme situation that occurred. The federal government could have been made aware of the impending situation if the Prime Minister had met with the former fire commissioners as they had requested. The federal government's slow response was not acceptable and a refusal to consider that the catastrophic situation was due to, or at least exacerbated by, climate change, was reprehensible. The public response to the fire threat was very admirable with stories of how local volunteer fire fighters faced the fire storm. The impact of the fires left many locals 'shell shocked' and many are still trying to put their lives back together. The support of other community members has been great and the state and federal agencies and voluntary organisations have been providing support to those affected. The Nymboida community in particular pulled together very well and Clarence Valley Council provided assistance where possible. There has been some frustration with the system relating to assistance but some issues are more complex than others such as the inspection and identification and removal of asbestos material from damaged or destroyed buildings. As I haven't had direct experience of these issues I will leave it to those who have to comment on the adequacy of the response.

1.4 Any other matters

The mental health of the residents of the Clarence Valley is a real issue. There are those that lost everything, those that lost some things, those that were threatened with losing their home (such as my wife and I) and those that were stressed by the enormity of the situation. A friend who lives in Grafton, a relatively safe area from bushfire, told me that she was stressed as she had experienced a threat from a bushfire in an urban area of the Blue Mountains some years back. I know that the mental health of people affected by the bushfires has been identified

by the response organisations and I hope that it has helped people to recover. We were hit with an extensive and intensive fire season, followed by floods and now Covid-19. Many people have been affected.
