I live in an area that was impacted by fire on the 4/1/2020 I am also a member of the rfs. Fire entered our community of 49 structures at 1.50 pm and myself and my husband and 2 sons all rfs members including the positions of senior deputy, area deputy, equipment officer all from Rocky Plain brigade watched as the fire came over a nearby hill as expected. We called for additional resources as the approaching fire was a spot over from the doubtful gap/ Dunn's road fire. Our captain declared us undefendable as the fire approached our village a decision that he had made four days before the fire entering the village. In the lead up to this fire State mitagation crews had done extensive hazard reduction works in our area to make our community defendable. National parks who's land borders our village have also run a program of mosaic burning for many years to mittagate the risk to our village. This work greatly contributed to the successful defence of our community by myself my husband and eventually 3

sons (3rd son Is a raft team member) defending the area from numerous spot fires all which were very defendable thanks to the previous work of both rfs mitagation crews and NPWS. Unfortunately our own RFS crews did not attend during the most critical 5 hours where our family managed to hold the fires from spreading. Had this defence not been achieved I hate to imagine the fire storm that would have engulfed the areas outside our village. The question I ask of this inquiry is was the response to this event adequate of rural fire service as it would appear from areas lost elsewhere NOT controlling fire where we can is detrimental to the adjoining areas. Fortunately we had one family well trained well prepared and well organised who stopped the spread of catastrophic fire to other areas. I also ask the question of rfs response in declaring an area undefendable after the same organisation spending considerable funds to declare the area defendable. At no time during the fire did we feel a threat to our life and I must stress we did not stay and defend to save our property but were very well aware of what the loss of this village would have caused in damage to areas surrounding us. This is the lesson that I feel rfs needs to learn, if you don't put out the fire you where manageable you risk life and property something as rfs members we are meant to uphold.
