Your story I live at haughwood rd Bora ridge

I have a family of 7 initially I was prepared for the 1st flood, I.e moved cattle and bought extra food and fuel as we are prone to flooding in this area.

I must say what started out fairly routine quickly became a nightmare.

I felt incredibly helpless listening to residents cry

for help throughout the region but in particular the bungawalbin creek.

I was monitoring river levels and too lost the most important reading when the indicator stopped registering bungawalbin south meter, which is still off line.

I felt that emergency services were massively undermanned and under resourced I could not believe there wasn't a single organisation taking control of the emergency, social media seemed to be the only source of up to date information and with the loss of cell towers etc this became worse. As did everyone we lost power very early and were trapped for around 3 weeks.

We rationed fuel and only ran the generator to keep the freezer going I had rang the ses and been told that I could only get help for personal emergencies. It wasn't until after 2 weeks of no power that my nephew boated me in some fuel and in the following days we volunteer boat drop fuel and hay and then a further drop of food from a helicopter unfortunately the food was pre cooked and without refrigeration could not keep. I registered for a hay drop however this was difficult as the cattle were in flood reserve and could not be located at the time.

I went and picked up hay after the three weeks in several loads.

Earlier saying I was familiar with floods I have always be able to get out much earlier however the road through the national park was impassable prior to the flood and therefore leaving us trapped.

The second flood we again were trapped for three weeks as the road still impassable We did get a food order online delivered by police helicopter.

My son cut his finger and had to be evacuated by boat to have surgery in Lismore, this time a feed drop was achieved for cattle.

We whole roads, driveways fences and dams to repair, ground we can't put Cattle on an debris to pick up. So far we have lost 6 head I fear this will increase.

We have had the property for seven years in that time we have put everything into the farm whilst working to bring the property up to a viable business. Many floods and fires have hindered this and of incomes while trying to build the farm and look after the land means no grants.

The emergency fodder was a one off 3 day allocation what happens to the cattle you have saved after three days when your trapped for six weeks and then after that you still can't put them back on flooded ground

Poor maintenance of haughwood rd through the national park (yaringully) nature reserve ment we were trapped for an additional two weeks in both floods also once maintained fire trails the reserve meant we could not escape that way also.
